Official Sweepstakes Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility:** Cargill® Pick Your Game Sweepstakes (the "Sweepstakes") is open only to persons who are a legal resident of one of the 50 United States and at least 18 years old at the time of entry. - 5. To Enter:** Go to www.pygsweeps.com or www.pickyourgamesweeps.com and follow the instructions for entry. Once you have submitted the required information, you will receive one (1) entry. Online entries must be received during the Sweepstakes Period. In the event of a dispute as to any online entry, the authorized account holder of the e-mail address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address.
